#### 1. Benson Street Issue:

Public Works Supervisor Caines & Public Works/Animal Control Randell attended the Council Meeting to discuss the issue on Benson Street.

There was a water leak that unfortunately happened while Public Works Supervisor Caines was on bereavement leave.

PW Randell advised there was a sewer issue at a property on Benson Street, the sewer issue was on the resident's end; however, resident decided to dig at their own sewer line & in the process digging up the pavement as well. The resident is responsible for his own sewer to the main; however, it is believed the main line was struck when completing the digging on own line.

CAO Collier & Public Works Supervisor Caines is suggesting for residents to consult with the Town Office to inspect prior to starting any water/sewer work on their own line.

## 4. Animal Control Policy:

Public Works/Animal Control Randell has advised that in order for the Town of Fortune to be adequately equipped to be able to utilize the Animal Control Building it will need to have running water/sewer.

The building is already heated; however, will need to be shingled & siding to be placed.

CAO Collier pointed out that the Town currently has siding advertised for Public Auction- if there is no interest in the siding we can utilize that for the Animal Control building.

## 6. Civic Numbering Incentive:

There was some discussion pertaining to a perceived conflict of interest for Mayor Hickman; however, discussion concluded there was no conflict; therefore, eligible for discussion and participation.

#### 7. Tax Relief Request:

Finance Committee had previously discussed & met with Business Owner as per this request.

Deputy Mayor Fleming advised Council that a request was received from a business owner regarding three different businesses within the municipality seeking credit/refund for 2020 and 2021 taxation years as business revenues were highly impacted by Covid-19 measures. Business owner seeking 100% rebate for all of municipal taxes (property, water/sewer & business).

Deputy Mayor Fleming advised that the Finance Committee as discussed with business owner were not willing to entertain any reduction on Commercial Property Tax or Water/Sewer but was willing to entertain a reduction of Business Tax as it was evident that the businesses have been severely impacted by Covid-19 (business owner disclosed revenues were down over 70% during the last two years).

The Finance Committee is recommending:

75% reduction in Business Taxes for 2020 & 2021 for account #FORTU004 & #HOTE.001

100% reduction in Business Taxes for 2020 & 2021 for account #ST0PI001

These recommendations will amount to a refund amount in the amount of \$5242.75 & adjustment in the amount of \$407.67.

#### 10. Winter Carnival Event:

Winter Carnival is scheduled for February 27th- March 5th, the Community Services Committee to scheduled to meet again tomorrow evening with the Recreation Commission to finalize the schedule.

The Town is sponsoring a free skate with hot chocolate & hot dogs.

There will be a "Mockey Game", Town of Fortune vs Recreational Hockey; therefore, need Councillors to participate if possible.

Mayor Hickman is encouraging all Council to participate in all events wherever possible.

## 11. Flow Meters Purchase:

The Finance Committee had initially discussed this matter & Deputy Mayor Fleming had inspected for further review. The Town of Fortune is currently leasing flow meters from BioMaxx and has received the option to purchase flow meters.

The purchase of flow meters is often eligible for funding via Gas Tax. CAO Collier to further review.

If the Town of Fortune purchased new flow meters from Biomaxx with the extended two year warranty it would result in more than \$36,000 in reduced operating costs over a three year period.

CAO Collier advised that when it is private property it is very hard for the Town to impose, the only thing the Town is legally able to do is write a letter & demand timelines to have the property cleaned up/repaired & if no action is taken for the Town's Public Works Employees to clean up the property & charge the property owner's tax account as it is potentially hazardous to other properties.
