The regular meeting of the Fortune Town Council was held on Monday October 25, 1993 with the following members in attendance Mayor Penwell, Deputy Mayor King, Councillors Reid, King, Thornhill and Warren.

It was moved by Councillor Reid and seconded by Councillor King the minutes of the October 4, 1993 meeting be adopted as read. Motion carried.

## Business arising from the minutes:

1. Debbie Hillier-granted her two weeks grace because of having to take her child to St. John's for medical reasons. Her water rates have been paid and part of her property tax.

It was moved by Deputy Mayor King and seconded by Councillor Thornhill that we give her another short extension until Lorne Piercey gets paid from the RAP program.

2. It was agreed that we get a clause put in the agreement with the B.P.I.S. B. re the 50ft. parking lot of Fortune Collegiate when it is sold.

3. Municipal Workers Agreement-accepted with the following changes:

Article: 9-9:01      Substitution of boots for rubbers

17:00 B      Bereavement pay for brother-in-law or sister-in-law-3 days instead of 1 day.

Also, workers want guarantee of no jobs lost. That would be the responsibility of the new council.

Deputy Mayor King to meet with the committee re (1) reductions of holidays deleted from the Shop Closing Act, and guarantee of jobs lost.

It was moved by Councillor King and seconded by Councillor Thornhill that we purchase a fly wheel and a distributor shaft for the International Truck. Motion carried.

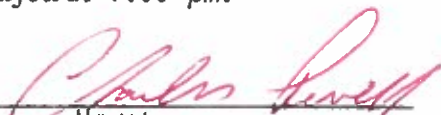
